RESOLUTION GRANTING SVMP DE, LLC'S APPLICATION FOR A SPECIAL USE PERMIT TO ALLOW A MIXED-USE BUILDING ON ITS PROPERTY LOCATED AT 1-49 SPRING VALLEY MARKETPLACE

WHEREAS, SVMP DE, LLC (hereinafter the "Applicant") is the owner of an 18.75 acre retail property located at 1-70 Spring Valley Market Place, identified on the Town of Ramapo Tax Map as 57.66-1-2.1 (the "Property") and has submitted a request for the Village Board to grant a special permit to construct at mixed-use building where the Christmas Tree Shop was previously located in the Village's PLI – Planned Light Industrial Zoning District; and

WHEREAS, the floor space previously occupied by the Christmas Tree Shops on the first floor will be replaced with four (4) separate retail tenant spaces and five (5) new office tenant spaces, the Applicant also proposes to increase the floor area of the building by 50,944 square feet,

with the addition of new second and third floors, which will both have a floor area of 25,472 square feet; and

WHEREAS, on May 4, 2023, the Village Planning Board declared its intent to be Lead Agency under the State Environmental Quality Review Act ("SEQRA"); and

WHEREAS, the Planning Board determined that this was an unlisted action under SEQRA and in preparing the SEQRA Part 1 and Part 2 found that the impacts associated with the proposal are small and can be mitigated thereafter adopting a Negative Declaration under SEQRA; and

WHEREAS, the Village Board opened the public hearing for this application at its August 1, 2023 meeting and thereafter closed the public hearing; and

WHEREAS, the Village had received comments regarding the proposed project from the Rockland County Commissioner of Planning pursuant to General Municipal Law § 239-L and § 239-M, dated April 6, 2023, which recommended denial of the application (see a copy of the Rockland County Commissioner of Planning's April 6, 2023 letter annexed hereto as **Exhibit** "A"); and

WHEREAS, on July 21, 2023, the applicant's counsel submitted a response to the Rockland County Commissioner of Planning's April 6, 2023, correspondence seeking an override of comments 1, 3, 4, 5, 14, 15, 16, 17, and 18 (see a copy of the applicant's July 21, 2023 letter annexed hereto as **Exhibit "B"**); and

NOW, THEREFORE, it is hereby resolved by the Board of Trustees as follows:
