LOCAL LAW AMENDING VILLAGE CODE § 239-7 VEHICLE FOR HIRE FLEET OPERATING LICENSE

WHEREAS, the Village Code and its various provisions have been adopted to serve the health, safety and welfare of the Village's residents, visitors, businesses, employees, and the general public; and

WHEREAS, from time to time the Village Board seeks to amend provisions of the Village Code to more effectively serve the health, safety and welfare of the Village's residents, visitors, businesses, employees, and the general public; while also maintaining an efficient form of government; and

WHEREAS, the Village has identified a potential improvement to the Village Code detailed in Chapter 239-7, specially modifying the Village Code with regard to requiring taxi fleet operating licenses which cover up to 25 vehicles when such provision is currently optional under the current Village Code; and

WHEREAS, a duly noticed public hearing was held on September 5, 2023.

NOW, THEREFORE, it is hereby resolved by the Board of Trustees as follows:

<u>Section 1.</u> The Village Board hereby ratifies and affirms each and every "Whereas" paragraph above.

<u>Section 2.</u> Amending Village Code § 239-7 to reflect the following changes, with deletions being marked with a strikethrough and additions being underlined:

Chapter 239. Taxicabs and Vehicles for Hire

§ 239-7. Vehicle for hire fleet operating license.

A. Any person, firm or corporation operating five or more vehicles for hire in the name of such person, firm or corporation may shall and must apply for a fleet operating license covering up to 25 vehicles. Each such vehicle shall be licensed and inspected in accordance with the applicable provisions of this chapter. The fee for such fleet operating license for the initial registration and the annual renewal thereof shall be as set forth in Chapter 118, Fees.

B. Any transfer or substitution of vehicles within the registration period shall be charged a fee per vehicle as set forth in Chapter 118, Fees. Such vehicle shall be registered and inspected.

C. Said reduction of fee shall be in recognition of the prohibition of said vehicles to cruise for passengers, accept hails, park at taxicab stands or in any other way obtain passengers, except through telephone requests.

Section 3. Numbering for Codification. It is the intention of the Village of Spring Valley and it is hereby enacted that the provisions of this Local Law shall be included in the Code of the Village of Spring Valley; that the sections and subsections of this Local Law may be re-numbered or re-lettered by the codifier to accomplish such intention; that the codifier shall make no substantive changes to this Local Law; that the word "Local Law" shall be changed to "Chapter," "Section" or other appropriate word as required for codification; and that any such rearranging of the numbering and editing shall not affect the validity of this Local Law or the provisions of the Code affected thereby.

Section 4. Severability. If any clause, sentence, paragraph, subdivision, section, or part of this Local Law or the application thereof to any person, individual, corporation, firm, partnership, entity, or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section, or part of this chapter, or in its application to the person, individual, corporation, firm, partnership, entity, or circumstance directly involved in the controversy in which such order or judgment shall be rendered.

Section 5. Effective date. This chapter shall take effect immediately upon filing with the Office of the Secretary of State of the State of New York.
