# RESOLUTION GRANTING A SPECIAL PERMIT TO ALLOW FOR THE CONSTRUCTION OF AN ADDITION IN EXCESS OF THREE (3) STORIES UNDER VILLAGE CODE § 255-27.1 AT 185 NORTH MAIN STREET

WHEREAS, the property owner of 185 North Main Street (hereinafter the "Applicant") has requested that the Village Board grant a special permit to construct an addition to the currently existing school in excess of three stories, pursuant to Village Code § 255-27.1; and

WHEREAS, the Applicant seeks to construct an addition which will provide a large gymnasium and additional classroom space to the property; and

WHEREAS, the Village Board votes to override the Rockland County Commissioner of Planning's correspondence provided under General Municipal Law § 239-M which recommended denial of the instant application.

WHEREAS, the Village Board held a duly noticed public hearing for the proposed special permit application on March 19, 2024; and

WHEREAS, the Applicant has agreed to provide a drainage plan, proper alarms and other safeguards to the building's entrance and exits which will be maintained safely.

NOW, THEREFORE, it is hereby resolved by the Board of Trustees as follows:

Section 1. The Village hereby ratifies and affirms each and every "Whereas" paragraph above.

<u>Section 2.</u> The Village Board grants the Applicant's special permit application allowing for the construction of a four (4) story addition to the school located at 185 North Main Street.

## RESOLUTION CALLING FOR AN INCREASE IN AID AND INCENTIVES FOR MUNICIPALITIES IN THE NEW YORK STATE BUDGET

WHEREAS, the Aid and Incentives for Municipalities Program (hereinafter "AIM") plays a critical role in funding essential municipal services for cities and villages across New York State; and

WHEREAS, city and village officials share the same priorities as our state leaders, which is to make New York safer and more affordable; and

WHEREAS, New York's local governments, who are on the frontlines of controlling property tax affordability and ensuring public safety, are integral to achieving those goals; and

WHEREAS, the State has not increased AIM funding in 15 years and according to the Bureau of Labor Statistics, inflation has increased by nearly 45% during that same period; and

WHEREAS, this neglect from the State has led to rising municipal tax burdens and harmful disinvestment in essential municipal services and staff; and

WHEREAS, the property tax cap further limits the ability of local governments to properly fund the services their residents need; and

WHEREAS, the challenges of rising inflation, the increasing costs of labor and supplies, and the end of extraordinary federal aid, only accentuate the need for an increase in AIM funding; and

WHEREAS, the Governor's 2024-25 Executive Budget proposes to keep AIM Funding Flat; and

WHEREAS, an increase in AIM funding would reduce the local tax burden and help revitalize communities across New York.

Now therefore, it is hereby resolved by the Board of Trustees as follows:

<u>Section 1</u>. The Village hereby ratifies and affirms each and every "Whereas" paragraph above and urges Governor Hochul to work with leaders of the Senate and Assembly to increase AIM funding in the 2024-25 adopted State Budget.

<u>Section 2</u>. A copy of this resolution shall be sent to Governor Kathy Hochul, Senate Majority Leader Andrea Stewart-Cousins, Assembly Speaker Carl Heastie, Senator Bill Weber, Assemblymember John McGowan and the New York State Conference of Mayors and Municipal Officers,
