WHEREAS, the Town of Ramapo has entered into a contract with LI Sweeping and Property Maintenance LLC dated August 14, 2023 – the Ramapo Contract – for sweeping services which includes a provision that LI Sweeping and Property Maintenance LLC shall provide sweeping services for all or any of the 12 Villages within the Town, including the Village of Spring Valley, as requested.

**NOW, THEREFORE,** it is hereby resolved by the Board of Trustees as follows:

<u>Section 1.</u> The Village hereby ratifies and affirms each and every "Whereas" paragraph above.
