Yvonne Lewis of Spring Valley a 13 year firefighter expressed the need for all firefighter to have proper safety equipment.

Jacques Oge, 1 Wood Street thanked the village for the progress of the potholes. Mr. Oge complained about the chickens running wild, train station smelling of urine and drug addicts all over the village.

Patricia Ellison of Gesner expressed the recklessness of taxi drivers and the traffic congestion is out of control.

Sherry Scott of Spring Valley of Hickory House complained about lights in Memorial Park and illegal taxis.

Roy Decosta of Spring Valley expressed his concerns of the parking on Bethune Blvd.

James Fraizer of Spring Valley complained of live wires on Bethune Blvd and asked if proper maintenance could be done in Memorial Park and to Memorial Park Pool as the children need a place to swim this summer.

Priscilla Brown of Spring Valley questioned who is in control of the lights in the park and expressed how dirty the park stays. Ms. Brown said there are certain parks in Spring Valley where everyone is not allowed in.

Eudson Francois expressed that one-way signs in the village are not respected, garbage is out of control on the streets and potholes are not being attended to.

Hank Baxter of Wood Street is concerned of the safety of his family, crime rate is going up, pollution in the village is out of control. Where is the Building Department? Where is the Fire Department? Please send letters to property owners to get the horrible conditions under control.
