RE: **POSTING OF POLITICAL SIGNS**

The Village Code requires that a temporary political sign permit be obtained before any political signs are posted to ensure that such signs are not posted so as to represent a danger to the public and are removed in a timely matter.

No signs may be posted on Village property. Signs posted on private property (with the owner's permission) must be placed, more than ten feet from the curb or the end of the roadway, if no curb is present.

A Village political sign permit does not authorize any signs to be posted on Village property.

The applicant and/or his/her agent understands that if the temporary political signs are not removed within **one (1) week** after the event or election, the Village is authorized to remove the signs and retain the deposit as reimbursement for its expenses.
